DHL Express

Name	Description	How we charge	Additional Charge	
<b>Fuel Surcharge</b>	This variable surcharge is applied to the weight charge of each shipment and any transportation related surcharges. It is derived from publicly available fuel oil indices that are also shown on the DHL Express website at <a href="http://dhl.co.kr/fuelsurcharge">dhl.co.kr/fuelsurcharge</a> . The charge is calibrated every month to the oil price that was current two months prior to the billing month. The Fuel Surcharge applies to domestic and international shipments. <b>Elevated Risk</b>	Additional surcharges may apply when shipping from or to a destination country where DHL is operating at elevated risk due to continuous state of war, civil unrest, or continuous threats from terrorism (Elevated Risk), or when shipping to a destination country that is subject to trade restrictions imposed by the UN Security Council (Restricted Destination).	Per shipment	KRW 25,000	
<b>Restricted Destination</b>	Additional surcharges may apply when shipping from or to a destination country where DHL is operating at elevated risk due to continuous state of war, civil unrest, or continuous threats from terrorism (Elevated Risk), or when shipping to a destination country that is subject to trade restrictions imposed by the UN Security Council (Restricted Destination).	Per shipment	KRW 50,000	
<b>Oversize Piece</b>	This fixed surcharge applies to every piece, including a pallet, with a single dimension in excess of 120cm. The Oversize Piece surcharge applies to international shipments.	Per piece	KRW 100,000	
<b>Overweight Piece</b>	A fixed surcharge is applied to every piece, including a pallet that exceeds a scale or volumetric weight of 70kg. The Overweight Piece surcharge applies to international shipments.	Per piece	KRW 100,000	
<b>Non Stackable Pallet</b>	This fixed surcharge is applied to every pallet within a shipment that cannot be stacked, either on request by the shipper, or because of its shape, content or packaging. This surcharge applies to international shipments.	Per piece	KRW 200,000	
<b>Remote Area</b>	This surcharge applies when a shipment is collected from, or delivered to a location that is distant or difficult to serve. The Remote Area surcharge applies to international shipments.	Per kg with minimum	KRW 30,000 per shipment or KRW 500 per KG if higher	
<b>Lithium Batteries, Section II</b>	A surcharge may apply for the handling and transportation of shipments involving specific types of Lithium batteries compliant with the appropriate IATA Packing Instructions 965, 966 and 969.	Per shipment	Lithium Ion P1965	KRW 120,000

<b>Excepted Quantities</b>	This fixed surcharge is applied per shipment when the handling and transportation of shipments involves substances and commodities that are in Excepted Quantities in compliance with IATA Dangerous Goods Regulations.	Per shipment	KRW 10,000	
<b>Dry Ice Un1845</b>	A service charge will be applied for the handling and transportation of Dry Ice UN1845, which is used as a freezing agent for non-dangerous goods.	Per shipment	KRW 24,000	
<b>Full Dangerous Goods</b>	A surcharge is applied per shipment when the handling and transportation of TDI shipments involves substances and commodities classified as fully regulated in accordance with the IATA Dangerous Goods Regulations. DG class 2, 4, 5, 6, 8 and 9 commodities, according to IATA regulations.	Per shipment	KRW 120,000	
<b>Address Correction</b>	This fixed surcharge is applied to any shipment that has an incorrect delivery address at the time of pickup and the delivery cannot be fulfilled after making efforts at the destination to determine the correct address. This surcharge applies to international shipments.	Per shipment	KRW 15,000	
<b>Data Entry</b>	This fixed surcharge applies for each shipment consigned with non-electronic, paper based manual waybills. Electronic shipping documentation incurs no additional charges.	Per shipment	KRW 6,000
